

## **Township of Scugog Social Media Account Terms of Use**

It is the Township of Scugog's policy that the following notice be posted in an obvious and prominent location on each corporate social media account established and maintained by The Corporation of The Township of Scugog ("the Township"), if such capability exists. The notice must also be posted on the Township website (scugog.ca) for easy access.

Social media sites are third party service providers that are collecting, storing, and managing your personal information whenever you access and use them. Please refer to the specific social media site's terms of service for particulars. Note that the Township has no control over what social media sites do with your personal information.

The Township may collect your personal information for the purpose of including your posts at this page and for the purpose of engaging in an interactive dialogue with you through social media, and does so under the authority of the *Municipal Act, 2001* (Ontario) but subject to compliance with the *Municipal Freedom of Information and Protection of Privacy Act* (Ontario) ("MFIPPA") and the Township's Records Retention By-law (the "By-law").

We wish to encourage the expression of thoughts and ideas but this must be accomplished in a respectful and lawful way. In making posts on social media sites, please respect the intellectual property rights of others. For example, do not post information containing copyrighted information or trademarks belonging to others.

If you wish to share a useful internet resource on this site, you may provide a hyperlink to that resource. Before posting the hyperlink, however, please ensure that the terms of use of the website to which you are linking permit the link. Links to any site that promotes the sale of any commercial product or service are not permitted.

Postings on this site do not necessarily represent the views and opinions of Township Council or employees. The information presented on social media sites is for convenience purposes only and the Township makes no representation about the accuracy or truthfulness of postings made by third parties. The Township will not be responsible to you or anyone else for any loss, damage, liability or expense suffered in connection with the use of this site or any of its content.
